All contractors are required to submit claims for all HHSC FPP services to TMHP, using the 2017 Claim form found on the TMHP website. The Texas Medicaid Provider Procedures Manual(TMPPM) provides detailed instructions of how to complete the form, including required and optional fields.

As claims administrator, TMHP processes claims for Medicaid services provided in the traditional, fee-for-service system. TMHP does not process claims for services provided by Medicaid managed care organizations (MCOs), but does collect encounter data from MCOs for use in evaluation of quality and utilization of managed care services.
