Court Jurisdiction and Venue for Adoption Petitions

The Circuit Court shall provide the alleged perpetrator the opportunity to appear and present testimony. The alleged perpetrator may subpoena any witnesses except the alleged victim or the reporter. However, the Circuit Court shall have the discretion to allow the parties to submit the case upon a stipulated record.
