Any person who shall wilfully disobey any lawful process, order, judgment or command of the court in any action in which injunctive relief is sought in any matter involving or growing out of a labor dispute, as defined in section twenty C of chapter one hundred and forty-nine, by doing any act or thing in or by such process, order ...

General Law - Part III, Title I, Chapter 220, Section 13A

Willful disobedience of a judge's command or of an official court order. An action that interferes with a judge's ability to administer justice or that insults the dignity of the court. Disrespectful comments to the judge or a failure to heed a judge's orders could be considered contempt of court.
