There are several ways to be charged for drunk driving in the state of New York. The basic charge is driving while intoxicated (DWI). Drivers who have a blood alcohol concentration (BAC) of 0.08% or higher or whos ability to drive is visibly impaired are charged with a DWI. A driving while ability is impaired (DWAI) is charged when the driver has a BAC of .05 to .07, or if

A driver can be charged with a DUI or DWI after failing a field sobriety test (which includes the testing of reaction time), even with a BAC below the state's legal limit. If a driver is under 21, some law enforcement policies may pursue DUI charges at blood alcohol level of 0.01%.
