### **PENSION ADMINISTRATION BULLETIN**

PBGC may terminate a pension plan – even if a company has not filed its own plan termination – if: The plan has not met the minimum funding requirements; The plan cannot pay current benefits when due; A lump-sum payment has been made to a participant who is a substantial owner of the sponsoring company, or; The loss to PBGC is expected to increase unreasonably if the plan is not terminated.

### **Pension Plan Termination Fact Sheet | Pension Benefit ...**

A terminating plan must be amended for all current law that applies to the plan and takes effect as of the date of termination. This is true even if the plan would not otherwise be required to amend the plan by that date based on the plan's remedial amendment cycle.

Termination of a Funded Pension Plan. In a standard termination, an employer decides to terminate a plan that is fully funded. If the plan is a defined benefits plan, the employer provides proof to the PBGC that there are sufficient assets to provide the benefits promised.

The National-Southwire Aluminum Company Pension Plan terminated in 1986 and was closed out by the purchase of two Prudential group annuity contracts. Sixteen years later, Prudential demutualized and issued a demutualization dividend of over 35,000 shares, worth \$1.3 million, with respect to the contracts.
