## **Hindu Marriage Traditions And Wedding Rituals**

-The Hindu Marriage Act, 1955, became law on the 18th May, 1955. It applies to all Hindus, Buddhists, Jains or Sikhs. It applies also to all other persons who are not Muslims, Christians, Parsis or Jews unless they establish that they were not governed by Hindu Law, custom or usage prior to the Act.

## **Hindu Marriage Act, 1955 - Bare Acts**

The Hindu Marriage Act, 1955 deals with marriage registration in case both husband and wife are Hindus, Buddhists, Jains or Sikhs or, where they have converted into any of these religions. It is to be noted that Hindu Marriage Act deals with only marriage registration that has already been solemnized.

## **Marriage Registration Laws in India - Complete Legal ...**

In India, by law and tradition, no Hindu marriage is binding or complete unless the ritual of seven steps and vows in presence of fire (Saptapadi) is completed by the bride and the groom together. This requirement is under debate, given that several Hindu communities (such as the Nairs of Kerala or Bunts of Tulu Nadu) do not observe these rites.
